All prices will be the same except we are upping the children's book to \$0.25 and media prices will be \$1.00. A Mystery Bag will be sold for \$2.00. Crystal also mentioned that 75 cars came through for the Shred Event and she thanked all the Friends members who volunteered throughout the weekend for the Shred Event and Festifall.

Old Business: The Financial Committee has still not met to update the by-laws. The Story Book Walk that was discussed last year will become an Eagle Scout project.

New Business: An attendance prize was drawn for an S4S T-shirt, Lisa Bromley was the winner. Debbie Row will bring an updated FOL membership list to pass out at the next meeting.
